Must show five (5) days and nights of Long Term Camping (i.e., 6/18/17-6/24/17 El Rancho Cima) and 10 days and nights of Short Term Camping (i.e., 1/12/18-1/14/18 Brazos Bend/Hiking). Camping dates before Fall of 2016 are not allowed (two year period prior to nomination).
